

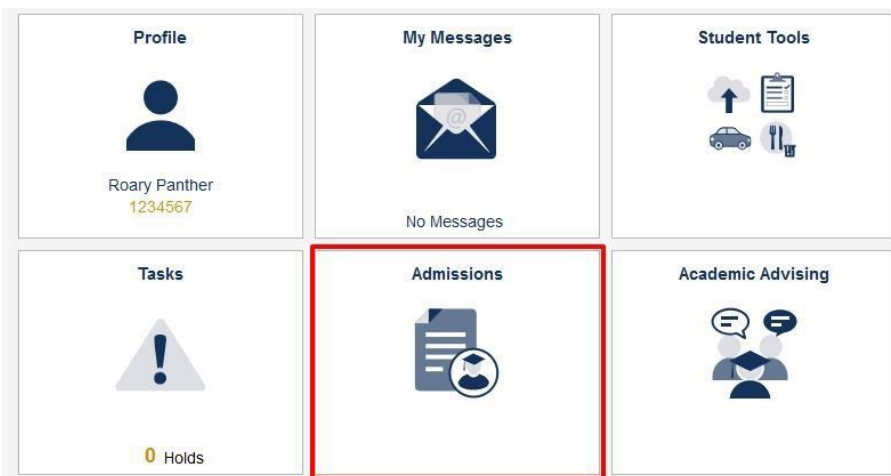
# Updating Your FIU Connect4Success Application

## 1. Log into [MyFIU](#).

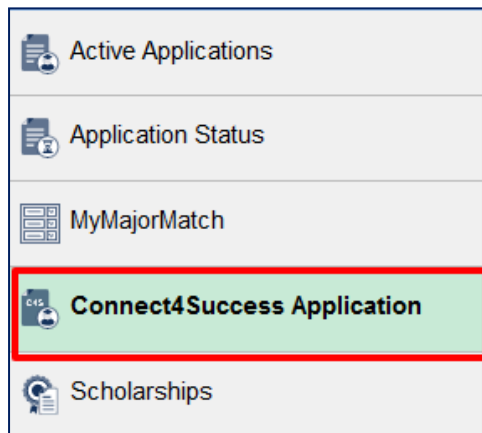
- If you do not know your 7-digit FIU Panther ID, go to: <https://login.fiu.edu/lookup/uid/>.
- If you know your password, you are required to enroll in Two-Factor Authentication (2FA) before proceeding. Go to: [AskIT Help](#).
- If you cannot retrieve your password, call FIU IT Customer Support at 305-348-2284, and choose Option #2 (Connect4Success students). After retrieving your password, enroll in 2FA. Go to [AskIT Help](#).
