

# FULL-TIME INTERNATIONAL MBA

The International MBA (IMBA) is a full-time daytime, one-year program consistently ranked among the top international business programs in the United States by *Bloomberg Businessweek* and *U.S. News & World Report*. Located in Miami, Florida, the “Gateway to The Americas,” this program is characterized by an elite group of students representing over 50 countries and 20 professions, completely immersed in international business. The curriculum exposes you to key issues in international business management, and provides insight into social, political, legal, and macroeconomic conditions relevant to conducting business in an international marketplace.

## PROGRAM FEES

Tuition for the International MBA Program (2020-2021) is approximately **\$21,139** for Florida residents and **\$47,000** for non-residents and international students, along with a non-refundable application fee of \$30.

## APPLICATION DEADLINES

The deadline to submit an online application to begin in the Fall Term (August) is **June 1<sup>st</sup>**. Supporting academic credentials and appropriate test scores must be delivered by **July 18<sup>th</sup>**. We encourage interested applicants to apply early because class size is limited. ## ADMISSION REQUIREMENTS

To be eligible\* for admission to the IMBA program, prospective students must:

1. Hold a four-year U.S. equivalent bachelor's degree from an accredited college or university
2. Minimum GPA (Grade Point Average) of 3.0 on upper-division coursework
3. GMAT/GRE

A GMAT waiver at the discretion of the academic director is available for:

- Applicants with two years of demonstrative work experience and success in completing other academic programs
  - Applicants who have an undergraduate business or related degree (economics, hospitality management, etc.) with an upper division GPA of 3.25, or higher
  - Applicants without a business or related degree having an upper division GPA of 3.35, or higher
  - If the applicant has already completed a graduate degree from an accredited university with a minimum GPA of 3.0
4. The TOEFL/IELTS exam is required for applicants who graduated from universities in non-English speaking countries. Achieve a minimum score of 550 on the paper-based TOEFL, 213 on the computer-based TOEFL, 80 on the Internet-based TOEFL, or 6.5 on the IELTS exam

\* Meeting the minimum requirements is not a guarantee of admission or a GMAT/GRE waiver

## SCHOLARSHIPS

Merit scholarships are available on a competitive basis. The average profile for a competitive recipient would be a GMAT of 600 or higher with a GPA of 3.25. However, the committee will consider applicants who may fall below these criteria.

Students will be responsible for additional fees and expenses.

Scholarships are subject to fund availability.

## APPLICATION CHECKLIST

- Graduate Application for Admission, along with non-refundable application fee of \$30.00.
- Official transcripts from all previously attended institution(s) must be sent in a sealed university envelope, directly to the Chapman Graduate School of Business.
- Official proof of degree: Applicants with foreign educational credentials must provide a copy of the original diploma. If not in English, it must be accompanied by a translation from a recognized translation agency or a certified translator. For domestic students, a photocopy of the diploma is required if degree is not posted on official transcripts.
- Current resume of professional experience (internships and part-time employment may be included).
- Official test scores sent directly by the testing office.
- Statement of purpose: a one-page essay describing your professional goals and reasons for pursuing the IMBA degree at FIU.
- U.S. applicants: proof of U.S. residency/citizenship.
- Florida residents: Two proofs of residency. Documents must be dated one year prior to the term you are seeking admission.
